I remember hunting deer near there but don't recall what it was that they mined there. They tunneled back quite a way as they worked it. I do know that one brother built a really nice cabin near South Fork from his mine profits. I once stayed at his cabin in the late 1970's with my young family and it was a very nice place, a mere 50 yards from the Rio Grande River. I was more interested in hunting and fishing back then.

I reiterate the need for caution when prospecting now that winter is upon us. Make sure that you are properly prepared by having all the proper equipment, plenty of food and water, and always let somebody know where you will be and when you will return.

CONFUSED ABOUT SCREEN SIZES, MESH NUMBERS AND ETC? Let's investigate this subject and see what shakes out.



As gold prospectors every one of us which is beyond the neophyte stage in our panning experience has at least one classification screen in our arsenal of tools. In the act of using the screen (or sieve) we take a mixture of various sized particles (sand & gravel) and attempt to shake it through the screen, in doing so we have divided the lot into two fractions. Those particles that passed through the screen (say the minus particles) and those that did not pass through (say the plus particles). In the US screen mesh is defined as "the number of screen opening per inch". So a #8-mesh screen will have 8 openings per inch in each direction and a #12-mesh will have 12 openings per inch. Note that as the number of openings and mesh number increase the size of the openings hence the particle size able to pass through decreases. Also note that since the openings per inch is fixed for a given mesh the thicker the wire used to make the screen the smaller the openings will be. Without standardization in manufacturing this can be a problem.

Because many of the uses for screens involve commerce and critical scientific testing, such as in assay labs, most screens are manufactured in accordance ASTM Specification E-11, by the American Society for Testing and Materials. This specification standardizes manufacture methods and materials of construction such as wire sizes and opening sizes, mitigating the above-mentioned wire size problem among others. As an example, with an 8-mesh screen ASTM to be 0.0937" not 0.125" (1/8") the difference is the wire size making up the screen defines the openings. Manufacturing limitations on minimum wire size make mesh ratings above 325-mesh impractical, so those particles are usually described in "microns". A micron is one-thousandth of a millimeter or one-millionth of a meter.

When specifying powder products you may read something like "-20 by +30 (mesh) Potash" which means that the powder has pass through 20 mesh and was retained on a 30 mesh screen. Typically 90% or more of the particles will be within the indicated range.

The following table illustrates the mesh size and other particle size characteristics of some common things.

The mesh numbers in parentheses are too small to exist as actual screen sizes; they are estimates included for reference.

GOLD RECOVERY HIBANKERS by Bob Butler

The processing, production and recovery capabilities of this multi-stage system, (3 and 4 stage recovery system), are far greater than most other hibankers using only the single riffle design. This design will process up to one cubic yard of unclassified gravel per hour with adequate water volume of 140+ GPM.

A very important part of this recovery system is its ability to separate and flush out the major portion of the unwanted light weight sand and





gravel while trapping the Gold and black sand values. This ability will save a lot of time, effort and expense when the concentrates are reduced down to the Gold and other values.

Each stage in this system is separate, containing its own hi-ribbed carpet and raised expanded metal. On clean up, this allows each section to be cleaned and tested until it is determined which section contains the highest percentage of gold. After many months of daily use, it is observed that the first stage in the hopper box retains the greater amount of gold and the other sections in line decreasing until the final section contains almost nothing. Since the first stage contains the most gold and also the least amount of sand, it should be "harvested" regularly and the next stages can be run much longer with



the final stage cleaned at the end of the day. Also checking this stage will tell if the gravel that is being processed has any gold or other value.

Coming Soon: A small attachment to the hibanker that will process the concentrates at the same time the equipment is running.

Sluicin' Sue

Into Thin Air

In January of 1859, George A. Jackson trudged up Clear Creek by himself and panned enough gold at the present site of Idaho Springs to make the first important placer gold discovery in Colorado. And he was also the man who hid \$10,000 worth or gold dust in buckskin bags that have never been found, even though the location is no secret, but definitely known.

The lost gold is not what he found in Clear Creek in January, 1859. He made another rich find high on the top of the range in Middle Park twelve years later. After Jackson made his first discoveries, he returned to serve in the Civil War and to farm in Missouri for se3veral years. Then he and a friend returned to Colorado to go prospecting and they made a strike

Realizing the strike was rich and fearing unfriendly Indians, the two men returned to Georgetown. They wanted to get together a dozen men or so to further explore the new area which was four or five miles from Rabbit Ears Peak. They had no trouble finding ten prospectors willing to go to Middle Park for gold. As soon as they reached the spot, they got to work building a camp with cabin and corral. Then Jackson, at the end of a hard day, relaxed by carving his name onto a tree at the corner of the cabin. In a short time, more than \$10,000 in gold was panned from the stream. The miners stored their wealth in buckskin bags and hid them under the earth in a corner of the cabin.

This was when a band of blood thirsty Indian warriors descended on the peaceful little camp high on the mountainside. The prospectors managed to hide and later made their way through the mountains and over Berthoud Pass to Georgetown. All but Jackson decided the West was far too wild for them and they returned to their Eastern homes. By now the heavy snows had started and it was impossible for Jackson to go back for the gold. He told a close friend where the mine and the hidden gold were, and they made plans to go there the instant weather permitted in the spring. But before spring



arrived, Jackson was recalled to Missouri on serious family business with the agreement that the friend would forward his share.


His friend and another miner made the journey into the wild country that June. On Walton Creek, near where the old Steamboat road crossed, they found the cabin and the corral. They also found the tree with Jackson's name on it. There could be no mistake, this was the place..! Eagerly, they went to work in the cabin, digging up the old dirt floor covered with debris. They turned the earth upside down from wall to wall, but they found no buckskin bags filled with gold. Jackson, they then decided, had been mixed up about his directions, so they kept on digging, not stopping until they had explored to a good depth all around the cabin, the corral, and under the tree with Jackson's name on it. But there was no gold!

Who had been in the deserted and lonely place since the Indians? Because of the heavy snows, it was unlikely that any white man had been there.

Maybe, and this is the more generally accepted theory, Jackson and his miners, wily and shrewd men that they were where their gold was concerned, really hid the gold farther away from the cabin, perhaps in some secret cave nearby. If so, it still awaits the lucky finder in that remote, sky high wilderness.
